GOLD WHISTLE AWARD WINNER: MARCY WESTON



The NASO Gold Whistle Award is given to an individual or organization that has made significant contributions to the betterment of sport officials and the officiating industry. This year's honoree will be the 21st honoree to receive the award, joining an elite group of past winners.



Few people, if any, can match the resume of Marcy Weston and the impact she has had on officiating. She has been a force behind the initial advancement of women in officiating and the vast improvement in overall officiating.

After a stellar on-court basketball officiating career, in 1985 Weston assumed the role of secretary-editor of the newly formed NCAA Women's Basketball Rules Committee, a position she held for more than a decade. In 1996, Weston was named the first-ever National Coordinator of Women's Basketball Officiating, a position she held until her retirement in December of 2005. She directly influenced the careers and lives of thousands of officials.

Weston served on the NASO Board of Directors from 1999-2003, including the Chair position in 2003. In 2006, she was presented the NASO Mel Narol Medallion Award. She was also a founding member of the Officiating Development Alliance and made numerous contributions to NASO Summits, including as a panelist and presenter. In November 2007, Weston was listed as one of 52 "Who Made Officiating" by the *Referee* staff.

MEL NAROL MEDALLION AWARD

NASO's Mel Narol Medallion Award recognizes outstanding contributions to the officiating community as well as NASO. The award winner will be the seventh such honoree and join other organizations or individuals as past recipients.



MEDALLION AWARD WINNER: ED T. RUSH

Rush served on the NASO Board of Directors from 1996-2000 and was Chair in 1999. He was an NBA referee for 32 years, including working Finals games from 1984-1997, and was the NBA Director of Officiating from 1998-2004.



Rush has been a longtime supporter of NASO and its mission. His impact on NASO is far-reaching. As the NBA's Director, he opened up dialogue between the NBA's officials and NASO, a relationship that is flourishing to this day. He lead that initiative in an effort to have the league's officials give back to — and be a part of — the officiating community.

In 2003, all NBA officials became NASO members — and still are today — a campaign largely influenced and supported by Rush. He has appeared at numerous NASO Summits, including hosting successful Leadership workshops for Summit attendees and for state associations. Rush also served on the Officiating Development Alliance.

His passion for teaching, accountability and leadership reflect positively on NASO. He has garnered a legacy of influence on NASO and the entire officiating industry.


